#### Discussion

#### Save St Marks:

- Correspondence has been sent by State Government to Local Government on 20/09/2021 to the effect that the land the church is based on will no longer be sold as part of the State's asset refreshment process; seeking direction from Local Government on how they would like to proceed as the property now falls entirely under Local Government jurisdiction
- It is noted that the land is owned for public purpose under the planning scheme and biodiversity values and bushfire risk should be considered in maintaining and restoring the property
- Community restoration efforts continue to develop
  - Funding required
    - Potential funding available through bodies such as the National Trust or the State Government Heritage portfolio
    - In-kind contribution can be monetised at a rate of \$40/hour
      - Bruce Fulcher has kindly offered weatherboard fabrication as a labour in kind service
      - Community members are encouraged to consider how they may be able to assist with restoration efforts
    - Ken Wyatt and Jessica Shaw have kindly noted that they may be able to offer prizes for fundraising efforts as donations
    - Other potential funding sources need to investigated, such as the Anglican Church
  - o Heritage protection will help to ensure longevity and integrity of restoration efforts
    - Previously assessed at state-level for heritage protection in 2004 assessment determined insufficient state significance
      - Report to be retrieved by Shire so that clarification can be sought on what the determining factors were for this decision
    - Alternately, the church may be able to be heritage protected at the local level, qualifying factors for local historical significance differ from those for state historical significance
  - o Protection from vandals required to stop further deterioration
    - Action required from Shire either directly (by protecting the property themselves) or indirectly (by providing community members with permission to enact protective measures like boarding up entrances)
  - o Community intent for usage of property once restored needs to be considered
    - What is the use? What is the function? What is the community purpose?
    - In terms of historical significance and potential tourism applications, relationship to Mahogany Creek Hall and Chidlow Hall as well as connections to Bunnings Mill and Sawyers Valley School House should be considered
    - Bullsbrook Sporting Centre is community operated and may therefore provide an exemplar

#### Wooroloo Fire Independent Inquiry:

- Enquiry is a joint effort from local Shires and State Emergency Recovery
- Post-public comment independent commissioner will review submissions made and prepare a report for publication and submission to the minister
- Submission date for public input extended to 08/10/2021

- Jessica Shaw is submitting anonymised data
- Jessica Shaw and team will be investigating why planning issues were excluded from terms of reference and highlighting issues raised by the community, including the management of increasing population density in relation to increased congestion on emergency egress routes

#### Bullsbrook Water:

• MH R&R continues to support the plight of affected Bullsbrook residents and will be submitting a letter of support to our Bullsbrook counterparts

Conclusion Although support may be available through state and federal representatives, further negotiations relating to St Marks will primarily happen at the shire level. Jessica Shaw will continue to advocate for local residents in the submission process for the Wooroloo independent fire inquiry.

#### Time allotted | 10 mins | Agenda topic Mt Helena Pool Update | Presenter Wade

Discussion Since its foundation two years ago, the Mt Helena Swim Club has expanded to 104 members. Recently, grants from Ken Wyatt have been used to secure new lane ropes, backstroke flags, and a marquis for use at swim meets. The new pool blanket is due for arrival – it was delayed due to a supply issue. However, the Mt Helena Swim Club remains the only Swimming WA affiliated club in the Perth metro area that does not have a year-round facility, which represents a serious disadvantage for our competitive swimmers and a service deficit for aquatic recreation. Currently, our swimmers have to travel to Belmont to train eight times a week – this is unsustainable and inequitable for swimmers whose parents are unable to support this travel. Despite this hardship, two of our swimming club members have qualified for state championships due to their talent and dedication, and we congratulate them on their achievement. In order to support continued engagement with and expansion of the Mt Helena Swim Club, the support of the shire is needed to increase availability of the pool for use.

Conclusion Lighting funding needs to be sourced to extend the season to 9 months alongside current solar heating and blanket. In order to extend to a full year season, a heat pump is needed, which will cost approximately \$50,000.
